Who we are

Data we collect

We collect data from the client using student forms, membership forms, healing client forms and website forms.

Clients will be asked to provide some or all of the following information:

- Name
- Address
- Email
- Phone Number
- Occupation
- Date of Birth
- · Emergency Contact details
- Areas of interest
- How they heard about us
- Previous experience in the field (if relevant)
- Medical conditions

We collect this information for the following purposes:

- For the provision of services and performance of contracts
- To uniquely identify the client for the purposes of recording their agreement to the School's Terms and Conditions and Privacy Policy
- To provide demographic information for the purposes of marketing
- To provide contact information so we can keep the client up to date with information about the school
- To provide contact information so we can inform the client of class changes or cancellations
- To provide emergency contact information so a relevant person can be contacted should the client become injured or ill
- To provide emergency responder medical personnel with relevant medical information should the client become injured or ill
- To ensure that we are aware of any medical conditions that would render any part of the class
 or treatment unsafe so we can advise the client accordingly, and modify or exclude parts of
 the class or treatment as appropriate for the health and safety of the client
- To administer the client's Membership
- To perform business accounting

You have the right to:

• Ask at any time to see what data we store on you

- Ask us to update our records if you believe we hold any incorrect information on you, in which
 case we will do so as quickly as practical
- Request the deletion of any personal data that is not otherwise required for legal purposes
- Withdraw your consent for your personal information to be used for marketing purposes

Retention

 We only keep your data for as long as is necessary or until appropriate consent has been withdrawn

Transfer of your information

- We may use third party service providers, such as Mailchimp and Microsoft cloud services, that may perform their processing outside the European Economic Area (EEA)
- We only use third party providers that implement appropriate privacy safeguards
- We do not sell your data to any third parties
- We may share your data in circumstances where we are required to do so by law
